BYLAW # 3/2008

A BYLAW OF THE RESORT VILLAGE OF WEE TOO BEACH TO REGULATE THE USE AND OPERATION OF ALL TERRAIN VEHICLES (ATV)

Pursuant to "The All Terrain Vehicles Act" 1988-89,c.A-18.02,s.9
The Council of The Resort Village of Wee Too Beach in the
Province of Saskatchewan, enacts as follows:

1 This bylaw may be referred to as the All Terrain Vehicle (ATV) Bylaw.

2 **DEFINITIONS**

For the purpose of this bylaw, the following terms and words shall have the following meanings:

- a) "all terrain vehicle" means self-propelled vehicle that:
- i) is designed primarily for the movement of people or goods on unprepared surfaces; and
- ii) has wheels in contact with the ground;

and includes:

- iii) a restricted use motorcycle;
- iv) a mini-bike;
- v) an all terrain cycle (quads) and
- vi) golf carts

but does not include:

- vii) a snowmobile as defined in "The Snowmobile Act"
- viii) any vehicle that is erquired to be registered pursuant to "The Traffic Safety Act".
- b) "highway" means a road, parkway, driveway, square or place designated and intended for or used by the general public for the passage of vehicles, but does not include any area, whether privately or publicly owned, that is primarily intended to be used for the parking of Vehicles and the necessary passageways on that area and does not include a provincial highway within the municipality as designated pursuant to the provisions of "The Highways and Transportation Act" 1997.

3 2 PURPOSE

The purpose of this bylaw is allow for the use of any/or all classes of "all terrain vehicles" on the travelled portion of all highways within the boundries of The Resort Village of Wee Too Beach as indicated on appendix "A" (excepting provincial highways).

H & RESTRICTIONS

a) Driver's Licence

 No person shall operate an all terrain vehicle within the boundries of Wee Too Beach, unless he or she holds a valid driver's licence as per 3(1) of The All Terrain Act.

b) Age of Operator

 No person under the age of 16 years shall operate an all terrain vehicle within the boundries of Wee Too Beach, pursuant to 1988-89,c.A-18.02,s.4. of The All Terrain Act.

c) Exemptions

- i) Any person of the age of 12 years or more but under the age of 16 years while operating an all terrain vehicle within the boundries of Wee Too Beach must be accompanied by a person of legal age who holds a valid driver's licence that permits him or her to operate the all terrain vehicle.
- "No person shall operate an all terrain vehicle within the boundaries of Wee Too Beach without a helmet according to Provincial Statutes."
